Here's a tool that can expedite the task of tying those vines up, while alleviating the task of twisting fingers to tie knows.



Culinary Corner

Tomato Curry Soup

Indian cuisine is one of the three great cuisines of the World, along with French and Chinese. Why, the only reason I suspect is because all three can use just about anything to make a great meal out of next to 'nothing'. With the Indians, it's mostly the herbs and spices.

It's easy to cook an Indian dish. Often in only ten min-

utes or so, except for soups, which take a little longer.

In truth, getting the ingredients of herbs and spices together is the most time consuming part of Indian cuisine. I keep a largish set of smallish



stainless steel bowls for getting them together. But the effort is worth the effort.

On the other hand, I've found that Indian dishes taste better the next day. Which means if you want it at its



best, make it the day before. Or make enough that there are leftovers.

The 'secret' to this—and other Indian dishes—is caramelizing the onions. It adds to the sweetness.

INGREDIENTS:

- 2 tbsp oil
- 1 onion, large
- 2 tomatoes, large
- 1 tsp cumin seed
- 1 tsp fenegreek powder
- 1 tsp cardamon seed
- 1 bay leaf
- 1 cloves
- 1/2 tsp turmeric
- 1 tsp chilli powder
- 1/2 tsp garam masala
- 1 1/2 cup tomato puree
- 1 tsp salt
- 1 cup water
- 2 tbsp cilantro leaves, chopped
- sour cream (Optional)

DIRECTIONS:

- [1] Heat oil in large pot and bring to medium heat.
- [2] Chop tomatoes and onions coarsely.
- [3] Add chopped tomatoes and onions to oil and sauté until onions are carmalized.
- [4] Grind cumin, cardamon, coriander, cloves into powder.
- [5] Add cardamon, coriander, cloves, cumin to hot oil. sauté sauté until they are aromatic.
- [6] Add other ingredients—less cream—to the pot and simmer.
- [7] When ready to serve, add sour cream.
- [8] Garnish bowls of soup with chopped cilantro leaves.

Be aware that as with many Indian dishes, the leftovers will be more flavorful the next day. Feel free to add more tomato puree or juice to mitigate, if it's too strong.



Book Review


Brave the Wild River: The untold story of two women who mapped the botany of the Grand Canyon

In 1938, two young women botanists from the University of Michigan embarked on a scientific excursion down the wild Colorado River.

They ran the rapids of what was considered the world's most dangerous river together with four men in three small wooden boats. Their goal was to "botanize" the Grand Canyon, that is, to discover, collect, identify and describe the plant life they found.

However, the novelty of anyone, let alone two women, braving the dangers of the Canyon was the story that captivated the public. All six survived the 43-day experience.



The women had collected hundreds of plants, including four that were previously unknown. A half-century later, one of the women was invited back on a much calmer trip through the Canyon to observe the changes that had taken place due to the creation of the Glen Canyon Dam and Lake Powell.

Melissa Sevigny's thoroughly researched book weaves plants, scenery, history and individuals into this fascinating true story.

Minutes of the Annual Meeting

May 18, 2024

Hilton Garden Inn Denver South Park Meadows

The official opening of the convention was called at 9:31 am by Victoria Schmidt, President. Victoria thanked everyone who put the convention together and welcomed everyone.

The Pledge of Allegiance was recited and the Conservation Pledge read.

The business meeting was called to order at 9:33 am by Victoria Schmidt.

Credentials Report: Pat Smit reported seven first time attendees, 39 members, and 11 presidents.

Adoption of Convention Rules: Sandy? presented the rules.

Treasurer Report: Pat Smit will be taking over the Treasurer's duties for the summer. She reviewed the report, which was included in the packet. Sue Parker noted that we have more members than are accounted for in the dues portion of the proposed budget. We will consider raising the amount at the next quarterly meeting. Chuck Pelto moved to file the reports and proposed budget. There was a second and the motion passed.

Secretary's Report: The minutes of the 2023 Annual Meeting were accepted with corrections.

Chair Reports: Debbie Martin reported for the Emerson House Trustees.

Doris Duckworth reported for the Smokey the Bear/Woodsy Owl youth programs and contest: we need sponsors for Elementary and Middle Schools.

Information and tips about signing up for the various NGC schools was shared.

Victoria reported on the Colorado Garden and Home Show. We had a good turnout and received a \$5000 grant for educational speakers. This money is available to clubs to help pay for speakers. We received the names of many people who are interested in joining a club. The Colorado Gardening Foundation sponsors the show.

Sue Parker reported that membership is up over last year, with 386 members. June 1 is the deadline to pay state dues and report membership.

NGC Convention: Victoria reported that we have a good turnout from Colorado. She has had to add buses

for the tours because of large participation. Close to 400 have registered so far. Workshops are full.

Victoria reported that Pat Smith has volunteered to serve as First Vice President. She has been appointed by the President. Chuck Pelto moved to ratify the appointment. There was a second and the motion passed.

Unfinished Business: Sue Parker mentioned that members in Gunnison (Top of the World Garden Club) have been greatly affected by a closed bridge which makes it difficult to reach services to the west. Michele Gustin mentioned that NGC has a disaster relief fund.

Victoria clarified that another club member can audit a club's books as long as they aren't on the board for the club.

Fort Logan is in need of a chair to coordinate one club a month to maintain the gardens. Some improvements are needed. Victoria pointed out that grants are available. A comment was that a map of what clubs need to maintain would be useful.

The contents of Emerson are being evaluated for storage needs, etc. Victoria's feeling is that most members would like to see money being spent in the clubs, not on Emerson House.

Memorial Service: Joy Kancir led the Memorial Service for members who have passed away during the past year.

Awards Ceremony: Michele Gustin, Awards Chair, presented Heart Warmer, NGC Grants, and other awards.

Michele announced that she will resign as Awards Chair in September 2024, so if you are interested, contact Victoria Schmidt and receive training from Michele.

There was a break in the proceeding while Judges Council met, lunch was served, and participants perused Silent Auction items.

Victoria announced that the 2025 meeting will be in June.

Amy Poston Lentz, CSU Horticulture and Landscape Architecture Department, presented a program show-casing Plant Select.

Final Credentials Report: Pat Smit submitted the final report. 35 club members were in attendance.

Gail Fischer presented the Courtesy Resolution.

A drawing was held for door prizes.

There being no further business, the meeting was

adjourned at 2:03 pm followed by workshops on Google Apps, Paper Flowers, and Centerpieces for the NGC Convention.
