Culinary Corner

Roasted Zucchini Disks

An excellent side dish for most any meal.

Ingredients:

2 Ea Medium Zucchinis1/2 Cup Garlic Bread Crumps

6 Tbls Parmesan Cheese, Fresh, Shredded

1 Tbls Cajan Seasoning

Salt Pepper

Directions:

- [1] Pre-heat an oven to 425 °F.
- [2] Cut off the ends of the zucchinis and slice into 1/2" disks.
- [3] Place the disks in a single layer on a sided baking pan.
- [4] Drizzle with olive oil.
- [5] Mix the parmesan cheese with the bread crumbs and olive oil.
- [6] Divide the cheese and crumbs among the disks.
- [7] Sprinkle the salt and pepper on the disks.
- [8] Bake at 425°F for 15-18 minutes. More time if using a lower temperature.

I have just started to clean up my raised beds. Since my soil is clay, this is how I grow my vegetables.



Exhibition and education event focusing on Membership, Exhibits, and Education

Goal: To recruit new members, reinvigorate and retain current members, provide a fun experience for members, and provide education and information on gardening, landscape, environment, and design to members and the public.

Designs: Open to experienced and novice designers. Display your designs or a tablescape as an individual, through your club, or as a group. We hope to have the designs and tablescapes reviewed by CFGC/NGC Judges (if we get volunteer judges) to provide education to members and the public on what judges look for in a design or tablescape.

Participants, members, and the public will have the opportunity to hear the Judges' thoughts on how they would judge the designs and tablescapes, how they could be improved, or why one would receive higher marks than another. This information is invaluable. It is crucial that experienced designers also participate to show examples of great designs that will help educate other members and the public. CFGC hopes to offset costs for entrants. The amount will be determined by the BOD at the December Quarterly Board Meeting. Presidents and Committee Chairs please attend or send a representative in your place to vote. If we don't have a quorum, we cannot provide this reimbursement.

Membership & Education: We will have tables with sign up sheets for potential members to ask to be contacted for questions or to get information on clubs in their area. We will also have tables for display boards, educational handouts, and flyers. Visitors to the Garden and Home Show will be able to pick up information to learn more about membership, gardening, landscape design, environmental issues and projects, and design information. Included in this area is a membership table where a host (or 2) are during scheduled times to have potential members sign up on the contact list and to provide educational and membership handouts or flyers to interested people.

We encourage clubs to provide flyers about their clubs. Be sure to include the locations your club servers and general information about your meeting dates, times, and locations (if in a public location). Do NOT include personal information about your members such as home address or phone number. If possible leave off personal email addresses. We encourage you to set up generic Gmail accounts for your officers and Committee Chairs such as GreeleyGCPresident@gmail.com or FASCMembership@gmail.com. Those accounts can be passed to the next person in that office or role and you can use that email on flyers and business cards without giving members personal information.

Presentations & Demonstrations: An area set up for live talks, presentations and demonstrations on Friday, Saturdays, and Sundays. Dates are Feb 24 and 25, March 1, 2, and 3, 2024. The show schedule will have up to three live demonstrations on each of those days, lasting 30 minutes (10 minutes of that is for Q&A).

Contact the CFGC Board & Membership Chair to suggest topics and/or to volunteer to be a host (man the booth for a couple hours) or to do a presentation or demonstration. We will also have an opportunity to display designs and/or enter a tablescape that will have the audience voting for the People's Choice award. Pass the word at your clubs and contact the CFGC Membership Chair, Annie Mollock to volunteer. Volunteers get into the convention for FREE! It can be a fun outing for your club members. Take turns hosting and walking around and checking out the convention. We need hosts and helpers on Friday, Saturdays, and Sundays. Other days are optional.

PLANT AMERICA Community Project Grants Guidelines and Application



The *PLANT AMERICA* Community Project Grants Program is sponsored by National Garden Clubs, Inc. for new or existing club projects in their respective communities. Projects may be a joint venture with another organization/s. The scope of these projects may include but are not limited to:

- Beautification and/or restoration
- Community gardens
- Youth gardening
- Habitat for Humanity landscaping
- Landscaping projects
- Implementation of environmental practices
- A horticulture or environmental educational event for the public

Grant Amount: Up to \$1,000.00 is available to be used for direct expenses of 2023 projects.

Who May Apply:

- Individual or near-garden clubs that are members of National Garden Clubs, Inc.
- NOTE: Recipients of previous PLANT AMERICA Community Project Grants are NOT eligible to apply.

How to Apply using this PDF form:

- Application is limited to a **TOTAL** of **two (2) pages**. (This page does not count.)
 - > **ONE (1) PAGE** Application Form (Page 1)
 - > ONE (1) PAGE Budget (Page 2)
- Applications of more than two pages will NOT be considered. NO PHOTOS/DIAGRAMS.
- Save this form to your desktop and open it in Adobe Acrobat; it is not fillable with most internet browsers.
 Fill in, save the changes and email the completed **application form** and **budget** to:

Application Deadline: October 15, 2022

- Recipients of grants will be notified, and all money will be awarded by January 31, 2023.
- Projects must be completed by February 28, 2024; final report forms due by April 1, 2024.

Judging Criteria:

In evaluating grant applications, judging is based on the following Scale of Points:

Benefits and visibility in community	40	Collaboration with other community groups	15
Impact and scope of project	25	Application form complete	5
Involvement & participation by club members	15	TOTAL	100

Funding Guidelines:

Grants will not be provided for:

- Projects in which club does not participate in some aspect
- Purchase of Blue or Gold Star Markers
- Competitive Flower Shows
- Scout projects
- Salaries or benefits of personnel
- Political action programs
- Capital drives and/or fund building
- Scholarships and/or endowments
- Private gardens
- Lawsuits and/or litigation
- Overhead costs
- Projects completed before 2023.

Final Report:

- 1. **Deadline:** within two months after the completion of the project or by April 1, 2024.
- 2. Email the following:
 - A short two-to-three pages report describing the project including photos
 - A copy of the final financial report including all income and expenses
 - A copy of any publicity

Board of Director Minutes

COLORADO FEDERATION OF GARDEN CLUBS, INC.

Quarterly Board of Directors Meeting Minutes September 8, 2023 via ZOOM

Present: Victoria Schmidt, Margie Soileau, Joy Kancir, Chuck Pelto, Susan Pelto, Ben Parker, Stacey Shockley, Michele Gustin, Jeanne Ricci, Deborah Trujillo, Debbie Martin, Deb Martinez, Sandy Edmondson. Sue Parker arrived later in the meeting.

The meeting was called to order at 12:32 pm by Victoria Schmidt, President.

Victoria welcomed everyone.

There was a discussion about quorum requirements. At 12:39 pm only 12 members were present, and a quorum is 14. The agenda was modified to take care of items that do not require a vote first. A quorum was present later in the meeting as noted below.

Directory, Victoria Schmidt: An updated version of the directory is available. Personal information will be available only through a private link to prevent scammers from accessing members' personal contact information. Chuck Pelto asked about removing personal contact info from the masthead of the Connection. Victoria thought it should be removed and a mask used to disguise who messages are going to. Victoria encouraged clubs to have "generic" email accounts that can be passed from officer to officer.

Technology Committee, Victoria Schmidt: Victoria reported that she has received 50 free licenses to Canva Pro for CFGC. She will make them available to clubs, CFGC officers and CFGC Chairs. The licenses will be tied to a Gmail account that the tech committee will set up. She announced a CFGC techie Gmail account is set up and we are using it for CFGC's YouTube and Zoom, so more people can take care of requests. The Tech Committee also reviewed information on website hosting. We are paying more and receiving less than what competitors offer. The Committee is recommending that we move to Wix. Money is available.

NGC Convention:

Victoria announced that through a discussion with the NGC President, it was determined that at this point they

only need \$2,250 for educational speakers, so CFGC will keep the rest of the \$5,000 which was approved unless NGC requests additional speaker funds.

The current NGC Conference Budget is set to have Colorado members pay only \$20 for registration at the NGC Convention, whereas those outside the state will need to pay \$50. Victoria cautioned this is still officially a draft and could potentially change but since it is in the approved budget it will hopefully be the final price.

There will be tours and discounted tickets to the Butterfly Pavilion, Denver Botanic Gardens, Betty Ford Gardens, etc.

Help is needed to get sponsors and donations.

Audrey Coyle is in charge of centerpieces and honor designs. She needs people to help with those.

Margie will handle the registration table. She needs volunteers to help staff the table.

District Updates

Northern Front Range District: Debbie Martinez, President, Greeley Morning Garden Club, encouraged people to attend on September 15.

Southern District: No report.

Emerson House Costs

A review of the yearly costs for Emerson House revealed that Emerson House costs us about \$24,000 per year with an income of about \$8,000. The Executive Board and the Ways and Means committee has asked that the Board of Directors indicate whether it is interested in pursuing the sale of Emerson House. A committee would be formed to investigate alternatives for storage, office facilities, legal implications, etc.

Emerson House Report

The House needs a new backflow preventer.

Sprinkler repairs will be about \$800-\$1,200.

Snow shoveling costs have gone up considerably.

D'Ann Carr has volunteered to be a trustee, but Joy Kancir and Carol Grant have left.

New flooring is needed in the kitchen and foyer, costing about \$6,500.

They'll be transplanting some sedum from the back to the front to keep the Squeegee from drifting out onto the sidewalk.

Margie will take over the calendar.

Margie commented that we have had several large expenses for Emerson House in the past several years. We will need to start using the Vanguard money to pay for Emerson House soon.

December 8th.

CFGC & NGC Benefits:

Victoria reviewed a detailed document she compiled on the benefits of CFGC and NGC membership for clubs, e.g., non-profit status, grant opportunities, etc. She will send to Presidents after the meeting.

Chairs & Clubs: Club/Chair reports or updates from the floor as needed: None.

Vanguard: Margie reported that investments have gone up.

CFGC Vacancies:

CFGC has vacancies for 1st Vice President, Chaplain, two Emerson House Trustees and Chairs for various Schools, Programs, FT. Logan National Cemetery, and Organizational Study. We really need a 1st Vice President. Since Annie Mollock has taken up some of the VP's duties, about all that is left is preparing the agenda and running the Ways & Means meeting.

Quorum:

Sue Parker joined the meeting, and a quorum was declared.

Motions:

Speaker Funds: Deb Martinez moved that we give \$125 to Douglas County Garden Club for a speaker on permaculture. There was a second and the motion passed. Emerson House: With the Executive Board's recommendation, Sue Parker moved, and Deb Martinez seconded that the Board of Directors wishes to pursue the sale of Emerson House and a committee be formed to look into the details. There was a second and the motion passed.

Minutes Approval: The March 2023 minutes were accepted as submitted. The Post-Convention minutes were accepted as submitted.

Financial Report: Margie Soileau, CFGC Treasurer, reviewed CFGC financial status. Vanguard: Joy Kancir reported. Chuck Pelto moved they be filed as submitted. There was a second and the motion passed.

Meeting adjourned.
